**NOTICE OF VOLUNTARY DISMISSAL**

These consolidated cases were brought under the Administrative Procedure Act to challenge a Department of Education regulation entitled “Nondiscrimination on the Basis of Sex in Education Programs or Activities Receiving Federal Financial Assistance.” 89 Fed. Reg. 33474 (Apr. 29, 2024) (“2024 Title IX Rule”). Since May 2025, they have been stayed pending resolution of appeals in two related cases that resulted in final judgment vacating that regulation. Doc. No. 92; *see Tennessee v. McMahon*, Nos. 25-5205 & 25-5206 (6th Cir.); *Carroll Indep. Sch. Dist. v. U.S. Dep’t of Educ.*, No. 25-10651 (5th Cir.). Both related appeals have now been voluntarily dismissed. Because the dismissal of these appeals means the underlying judgments vacating the 2024 Title IX Rule are final, this case is now moot.

Accordingly, Plaintiffs file this notice of voluntary dismissal pursuant to Federal Rule of Civil Procedure 41(a)(1)(A)(i).
