PRODUCT/FIRM: Arsell Recalls Benadryl Liquid Elixir 100 mL Bottle Due to Risk of Child Poisoning; Violation of Federal Regulation for

Child Resistant Packaging; Sold on Amazon.com **DESCRIPTION:** This recall involves Benadryl Liquid Elixir sold in a round dark plastic bottle with a pink and white label on the front with the word "Benadryl" in blue text. The product contains 100 mL of Benadryl. The back label contains safety disclosures, storage instructions and manufacturer information. The product was packaged in a paper box decorated with pink and white with the word "Benadryl" written in blue text. The package has a white label on the bottom with the following code written in black text: "X003VRIGUL.".

REMEDY: Consumers should immediately stop using the recalled merry-go-rounds and contact the owner of the equipment, such as park director or school principal, to determine if equipment has been inspected and repaired. Contact BCI Burke to schedule an inspection and free onsite repair.

PRODUCT/FIRM: Segway Recalls Segway Ninebot Max
G30P and Max G30LP KickScooters Due to
Fall Hazard and Risk of Serious Injury

DESCRIPTION: This recall involves all Segway Ninebot Max G30P and Max G30LP KickScooters. The Max G30LP KickScooter

is gray in color with yellow accents and the Max G30P is black in color with yellow accents. The brand name "ninebot" appears on the foot platform and the top of the

handlebars. The model number is located on a label on the side of the foot deck. The Max G30P model is 46 inches long, 19 inches wide, 47 inches high and weighs 42 pounds. The Max G30LP model is 44 inches long, 19 inches wide, 45 inches high and weighs 39 pounds. **REMEDY:** Consumers should immediately stop using the recalled scooters and contact Segway to receive information to determine whether the folding mechanism needs adjustment and to receive a free maintenance kit. The kit includes tools and instructions for checking and tightening the folding mechanism and keeping it properly maintained.

DESCRIPTION: This recall involves Onasti-branded toddler stools. The plastic, foldable, triangular-shaped tower stools were sold in beige/white, blue/gray, green, gray/white, light blue and pink. They measure about 25 inches long, 24 inches wide and 32 inches tall, and have handles and an adjustable platform that can be raised or lowered from two to three steps. The Onasti logo appears on the warning label on the side of the stools. REMEDY: Consumers should stop using the recalled stools and store them away from children until repaired. Contact Blissful-Time to receive a free repair kit, including shipping. The repair kit consists of two steps, one base, and one guardrail. Blissful-Time is contacting all known purchasers directly.

DESCRIPTION: This recall involves Chews Life Silicone Rosary teethers including models Assisi, Little Flower, God's Grace, Cecilia, John the Baptist and Divine Mercy, and Chews Life Silicone Decades teethers including models Genesis, Maccabees, Ester, Wisdom, Divine Mercy, Psalm and Proverbs. The recalled teethers are made of multi-colored beads with a cross at the end. Each teether has a two-piece safety snap clasp. REMEDY: Consumers should immediately stop using the recalled teethers and contact Chews Life to receive a free repair. Consumers will be provided with a prepaid shipping label to return the recalled teethers to Chews Life. Chews Life will mail consumers the repaired teethers at no charge.

PRODUCT/FIRM: Safety Gates Recalled Due to Risk of Serious Injury or Death to Children from Entrapment Hazard; Violation of Federal Regulation for Gates

and Enclosures; Sold Exclusively on Amazon.com by HabiLife Direct

DESCRIPTION: This recall involves retractable safety mesh gates, marketed as baby or dog gates, with model number SG021. They were sold in white, gray and black. The multi-use gates measure about 34 inches high with an adjustable width up to about 55 inches and have an aluminum frame. "Retractable Safety Gate" and the model number are printed on a white label located on the inside of the frame on the side of the gates' handles. REMEDY: Consumers should stop using the recalled gates immediately and contact HabiLife Direct for a full refund. Consumers will be asked to destroy the gates by cutting the mesh and disposing of the gates. Consumers

DESCRIPTION: This recall involves 100% polyester hooded dinosaur children's bathrobes. The flannel bathrobes are green and have attached belts and patch pockets. The size, manufacturer information and care instructions are printed on sewn-in labels inside the left inseam of the robes. They were sold in sizes 2-3 years, 3-5 years, 6-8 years, and 8-10 years.

REMEDY: Consumers should immediately stop using the recalled bathrobes, take them away from children, and contact Nanchang Zhongcangjishi E-commerce for a full refund. Consumers will be asked to destroy the garments by cutting them in half and emailing a photo of the destroyed garment to business@lolanta.com. DESCRIPTION: This recall involves seven styles of Marie-Chantal children's 100% organic cotton or 100% pima cotton nightgowns, three styles of children's pajama sets and two bathrobe styles. The nightgowns were sold in white with a bird print, white with a feather print, white with a bunny print, white with multicolor dots, pink or pink and white with a star and crown print, white with a pink

flower print, and pink with a kitten and tea pot print. The children's two-piece pajamas were sold in pink with a kitten and tea pot print two-piece pajama set, golden crest two-piece pajama set, and pink or cream with an angel wing print. The robes were sold in white and pink or white and blue color combinations with a star and crown print, and plain white. The nightgowns and pajama sets were sold in children's sizes 2 years through 10 years, and the robes were sold in sizes small, medium and large. "Marie-Chantal" and the RN number 103490 are printed on a sewn-in seam label.

REMEDY: Consumers should immediately take the recalled children's garments away from children, stop using them and contact Marie-Chantal for a full refund. PRODUCT/FIRM: Costway Recalls Babyjoy High Chairs Due to Entrapment and Suffocation Hazards; Ban on Inclined Sleepers and Violation of Federal Regulations for High Chairs

DESCRIPTION: This recall involves all Costway's Babyjoy high chairs. The

collapsible high chairs were sold in pink (model BB5656PI), beige (model BB5656BE) and gray (model BB5656GR), and have a footrest, a detachable tray, pink or gray or beige seat cushion with stars, and four static wheels with locks. The high chair can be adjusted for different heights and recline positions. "Babyjoy" is printed on the front of the detachable tray. "Goplus Corp." is printed on a label located on the back of the high chair's seat. The model number appears on the product packaging.

DESCRIPTION: This recall involves Style Life Eleven baby loungers. The loungers include a head pillow and fold into a portable handbag with a handle. When folded into the portable handbag, the brand name "Style Life Eleven" is visible on a white square in cursive font. The loungers were sold in different printed fabrics including Dinosaur, Blue & White Crowns, Dotted Pink, Dotted White & Purple, Zoo Animals, and Gray & Brown Crowns. Only portable loungers purchased on or after June 23, 2022, are included in this recall.

DESCRIPTION: This recall involves P.J. Salvage Kids Checker Plush Short Sets, Fleece Pajama Sets, Smiley Plush Robes and Tie Dye Plush Sets. The Girl's Checker Plush Short Set, model RP3KHST, is a pullover hoodie with a kangaroo pocket, long pants and shorts, and was sold in gray with stars and lilac with checkers. The Kid's Fleece Pajama Set, model RP3KPST, is a pullover crew with a kangaroo pocket and jogger pants and was sold in a multi color tie dye pattern. The Girl's Smiley plush robe, model RP3KPR, is a hooded robe with front pockets and a waist tie and was sold in pink lilac with smiley faces. The Girl's Plush sets, model RP3KFST, is a fleece set with a pullover crew top and jogger pants and was sold in lilac ice with a "Smile" graphic on the front, in multi color with a "Good Vibes" graphic on the front and in sky blue with a "Sunshine" graphic on the front. DESCRIPTION: This recall involves the Sauder tip-over restraint straps that were sold and distributed with certain Sauder dressers and 4-drawer chests manufactured between July 2020 and August 2023. The clothing storage units have a date of manufacture sticker on the back of the unit. They were sold in various colors under the Sauder and Sauder Beginnings brands.

REMEDY: Consumers should immediately check if their clothing storage unit has a date of manufacture sticker on the back of the unit, between July 2020 and August 2023. If so, consumers should contact Sauder to arrange for a free replacement tip-over restraint kit to be mailed to the consumer at no cost. Consumers should remove the old tip-over restraint and install the new one once received. Keep children away from the unit while waiting for a replacement tip-over restraint kit.

DESCRIPTION: This recall involves Rebecca's Toys & Prizes bowling pin sipper cups. The cups are white with red tape on the neck and a red plastic cap. The words "ITEM NO. PG1045", the brand name and the firm's address are printed on a white label located on the side of the sipper cup.

PRODUCT/FIRM: Walmart Recalls Swagtron SG-5 Swagger 5 Boost Commuter Electric Scooters with Lithium-Ion Batteries Due to Fire and Burn Hazards; Risk of Serious Injury and Death

DESCRIPTION: This recall involves SG-5 Swagger 5 Boost Commuter Electric Scooters sold at Walmart and Sam's Club. The electric scooters are powered by lithium-ion batteries. They were sold in black or silver colors. "SWAGGER 5" is printed in large lettering on the stem of the handlebars. The lithium-ion battery is located beneath the scooter deck. The model numbers are SWGR5-V2-SLV, SWGR5-V2-2, SG5 Boost, SG-5S, 96262-2, 96262-9, SG-5S, and 96560-2. The model numbers are affixed to the side of the scooter deck. Note: Recalled lithium-ion batteries should be disposed of in accordance with any local and state ordinances, following the procedures established by your municipal recycling center for damaged/defective/recalled lithium batteries, because these potentially hazardous batteries must be handled differently than other batteries. Do not throw this recalled battery in the trash. Do not deposit this recalled battery in used battery recycling boxes found at various retail and home improvement stores.

The manufacturer, Swagtron, of South Bend, Indiana, has not been responsive to CPSC's request for information about this product or to CPSC's request for a recall. However, Walmart as the retailer has agreed to recall electric scooters that were purchased at Walmart or Sam's Club either at its stores or on its websites.

REMEDY: Consumers should immediately stop using and charging the recalled electric scooters, cut the throttle cord, and dispose of the entire product following local and state hazardous waste disposal procedures. Consumers who purchased their electric scooters from Walmart or Sam's Club will receive an email with instructions on how to receive a full refund.

PRODUCT/FIRM: AFTCO Recalls Youth Solitude Jackets with Drawstrings Due to Strangulation Hazard

DESCRIPTION: This recall involves the black Youth Solitude Rain Jacket sold in youth sizes XS through L. They are made

with waterproof nylon, have a retractable drawstring in the hood and have the AFTCO logo on the front. The internal label has the company's logo above the size, care instructions, fiber content and country of origin information. The model number is BJ05. The jackets are black and were sold in the following size ranges: XS (5-6), S (6-7), M (8-10) and L (10-12).

REMEDY: Consumers should immediately take the recalled jackets away from children and remove the drawstrings to eliminate the strangulation hazard. PRODUCT/FIRM: 6-in-1 Pounding Games Recalled Due to Ingestion Hazard; Violation of Federal Regulations for Magnets; Sold Exclusively on Temu.com by DMITOY.

DESCRIPTION: This recall involves the 6-in-1 Pounding Game that consists of a wooden frame with a frog clock on each end. One side of the game has a xylophone, and the other side has three colorful gears. The top of the game has circular holes and wooden pegs with animal faces that pop up and down. The game comes with a set of wooden carrots and worms with metal heads that fit in the holes. Two wooden mallets, two wooden sticks, and a wooden bird are included with the game. The bird has a strong magnet embedded in its beak and can break off.

REMEDY: Consumers should stop using the recalled pounding games immediately and take them away from children. DESCRIPTION: This recall involves the Spritz Taper Resin Hanukkah Dino

Menorah. The menorahs are blue, made of polymer resin and measure 6 inches high x 13 inches long. They can hold up to nine tapered candles in the metal candle cups located on the dinosaur's back. The model number "240-14-1380" is printed on the product's hang tag located on the dinosaur's neck.

REMEDY: Consumers should immediately stop using the recalled menorahs and return them to any Target store for a full refund in the form of a Target gift card or refund in the original form of payment. Consumers may also contact Target to receive a prepaid return label to return the menorah by mail.
