PRODUCT RECALLS

PRODUCT/FIRM: TADAKAZU Baby Loungers Recalled



Due to Risk of Serious Injury or Death from Suffocation, Fall and Entrapment Hazards; Violations of Federal Standard for Infant Sleep Products; Sold on Amazon DESCRIPTION: This recall involves

TADAKAZU baby loungers. The baby

loungers are made of a cloth cover with a foam sleeping pad and padded bumpers. There is a tag on the bumpers of the baby loungers with the brand name "TADAKAZU" printed on it. The baby loungers were also advertised as "baby nests" and were sold in the following prints, colors and model numbers:.". CONSUMER CONTACT: TADAKAZU by email at tadakazurecall@yeah.net.

REMEDY: Consumers should immediately stop using the recalled baby loungers and contact TADAKAZU for a full refund. Consumers should remove the sleeping pad, cut up the sides of the baby loungers and the sleeping pad, and email a photo of the destroyed lounger

to <u>tadakazurecall@yeah.net</u> to obtain a full refund. TADAKAZU and Amazon are contacting all known purchasers directly.

PRODUCT/FIRM: Peg Perego Recalls Tatamia 3-in-1



Recliners, Swings and High Chairs Due to Risk of Suffocation; Violations of Multiple Federal Standards (Recall Alert) DESCRIPTION: This recall involves Peg Perego Tatamia recliners, swings and

high chairs. The products convert from a recliner to

a high chair and to an unpowered infant swing, and they were sold in "Ice" (gray) color with model number IMTATANA01BL73. The top of the padded leather seat has the brand name "Peg Perego" printed on it. In high chair mode "Peg Perego" is printed on the front of the tray. The adjustable side of the product has "tatamia" printed on it. Only products manufactured on or after June 23, 2022, and/or purchased on or after November 12, 2022, are included in this recall. The manufacture date in YYYY/MM/DD format and model number can be found on the base of the product.

REMEDY: Consumers should immediately stop using the recalled products and contact Peg Perego for a full refund. Consumers should contact Peg Perego for a prepaid shipping label and packaging to send the products back to Peg Perego. Peg Perego and Amazon are contacting all known purchasers directly.

PRODUCT/FIRM: Boyro Baby Walkers Recalled Due to Risk of Serious Injury or Death to Children from Fall Hazard; Violations of the Federal Standard for

Infant Walkers and Lead Content Ban; Sold Exclusively on Amazon.com

DESCRIPTION: This recall involves Boyro Baby's baby walkers, model number US-B01. The plastic walkers

were sold in black, blue and gray with five levels of height adjustments. They have a black or gray rotating seat, a matching footpad, six wheels and four removable toys (an owl, a flower, an arch with a ball and a three-button panel that plays music and lights up.) "Ready To Ride" appears on a label on one of the walker's legs and the height-adjustment buttons are on another leg. "Boyro Baby" and the model number are printed on the tracking label, located under the seat cushion.

REMEDY: Consumers should stop using and disassemble the recalled baby walkers immediately and contact Boyro Baby for instructions on receiving a full refund. Consumers will be asked to destroy the disassembled baby walker and email three photos of the destroyed product to boyrobaby@outlook.com. Once the three photos have been received, Boyro Baby will issue a refund. Boyro Baby and Amazon are contacting all known purchasers directly.

PRODUCT/FIRM Bell Sports Recalls Bicycle Helmets Due to Risk of Head Injury; Violation of Federal Standard for Bicycle Helmets.

DESCRIPTION: This recall involves Bell Sports' Axle, Cadence, Rev and Frenzy children's bicycle helmets with model numbers B0605Y, B0605C or B0494Y, and Cadence and Passage adult helmets with model number B0605Y. The helmets were sold in the following colors or color combinations: blue, green, purple, red, pink, black/blue, green/black, pink/green, pink/purple, pink/white, purple/white, red/black, pink/mint or multicolor; and have various designs, including checkers, lines, polka dots, rainbows and swirls. The model name, the model number, and the manufacture date in MM/YY or M/YY format can be found on a sticker inside the

helmet.

REMEDY: Consumers should stop using the recalled helmets immediately and contact Bell Sports for a full refund. Consumers should destroy the recalled helmet by cutting the straps off the helmet. Consumers can upload photos of the helmet with the straps cut off to consumersupport-bell@bellhelmets.com to obtain a refund. Bell Sports is contacting all known purchasers directly.

PRODUCT/FIRM: Bugaboo North America Recalls Giraffe High Chairs Due to Risk of Serious Injury or Death from Fall Hazard DESCRIPTION: This recall involves Bugaboo Giraffe highchairs. The

highchairs measure about 30 inches tall, 21 inches wide and 23 inches long. The highchairs were sold in blue, black, natural wood/white, warm wood/gray and white with the item codes listed below. The item codes are located on the bottom of the seat.

REMEDY: Consumers should immediately stop using the recalled highchairs and contact Bugaboo to receive a free repair kit including an Allen key and new screws to install into the product's legs. Bugaboo is contacting all known purchasers directly.

PRODUCT/FIRM: Funlio Convertible High Chairs Recalled Due to Risk of Serious Injury or Death from Fall and Entrapment Hazards; Violation of Federal Standards for High

Chairs; Sold by Ecogoods.

DESCRIPTION: This recall involves 2-in-1 Funlio Baby High Chairs that convert into a chair and table for children as they grow. The high chairs are made of natural wood with a tray and removable padded seat insert that is green with a forest theme. "Funlio" is printed on the top front of the high chair and on a tracking label underneath the tray. "Model FL-039" is also printed on the tracking label.

REMEDY: Consumers should stop using the recalled high chair immediately, disassemble it and contact Ecogoods for information on how to receive a full refund. Consumers will be instructed to cut the restraint straps and email photos of the disassembled and destroyed components

PRODUCT/FIRM: Portable Hook-On Chairs Recalled Due to Risk of Serious Injury or Death from Fall Hazard; Violation of the Federal Standard for Portable Hook-On Chairs; Sold Exclusively on Amazon.com by Ravmix DESCRIPTION: This recall involves

portable hook-on chairs used to seat young children at the table. The chairs have a black metal frame covered with black or gray polyester and cotton material and a white plastic tray used for eating. There are two metal arms that anchor to a dining table and the child is suspended from the table. "Children's table chair" and "Model S006" are listed on the owner's manual.

REMEDY: Consumers should stop using the hook-on chair immediately and contact Ravmix for information on how to receive a refund. Consumers will be instructed on how to disassemble the product, cut the restraint straps and cloth seat, and email photos of the disassembled product and parts to Ravmix. Upon receipt of the photos, Ravmix will issue a full refund. Ravmix is contacting all known purchasers directly.

PRODUCT/FIRM: ZHORANGE Portable Bassinets Recalled Due to Risk of Serious Injury or Death from Fall Hazard; Violation of Federal Standard for Infant Sleep Products;

Sold on Amazon.com by DFD Trading.

DESCRIPTION: This recall involves ZHORANGE portable bassinets with model number 148012-A. The gray portable bassinets include a head pillow and fold into a portable handbag with a handle. When folded into the portable handbag, the brand name "ZHORANGE" is visible in large, white block letters. The inside of the bassinet has black polka dots on the sides. There is a tag with the model number and date of manufacture in the YYYY.MM format.

REMEDY: Consumers should immediately stop using the recalled portable bassinets and contact DFD Trading for a full refund. Consumers should remove the sleeping pad, cut the sides of the portable bassinets and the sleeping pad, and email a photo of the destroyed bassinet to zhorange8695@gmail.com to obtain a full refund. PRODUCT/FIRMHobby Toy Hammer Ball Sets Recalled Due to Risk of Serious Injury or Death from Choking Hazard; Violation of Federal Regulation for Toys with Small Balls; Sold Exclusively on Amazon.com by Shantou Haochengheng Technology.

DESCRIPTION: This recall involves Hobby Toy Hammer Ball sets with model

number 711. The model number is printed on the label of the product packaging. The toy set consists of a base with buttons, a detachable door, four small detachable basins, and a standing sign with a monkey. "FOREST ROLLER BALL" is printed on the green base of the toy sets. "ROLLER BALL" is printed on the brown gate and "FISHING" is printed on the side of the hammer on these toys. The hammer ball sets measure 15 x 10.6 x 13.2 inches and come with a hammer and four small colored balls. The balls measure about 1.5 inches in diameter and were sold in yellow, light pink, dark pink and blue.

REMEDY: Consumers should stop using the recalled toys immediately and contact Shantou Haochengheng

PRODUCT/FIRM: ZRWD Infant Swings Recalled Due to Risk of Serious Injury or Death from Suffocation Hazard; Multiple Federal Safety Violations; Sold Exclusively on Amazon.com by ZRWD.

DESCRIPTION: This recall involves ZRWD infant swings with model number

S0008A. The swings were sold in gray and white fabric with a black base, and blue and while fabric with a white base. The swing includes a remote control with a lithium CR 2025 3v button cell battery, two plush toys (moon and star) and an activity tray.

REMEDY: Consumers should immediately stop using the recalled infant swings and contact ZRWD for a full refund. Consumers should send a photo of the swing cover cut in half and of the swing with "Recalled" written with permanent marker on its base

to <u>zrwdrecall@163.com</u>and then dispose of the swing. ZRWD and Amazon are contacting all known purchasers directly.

PRODUCT/FIRM: The Step2 Company Recalls My First Snowman Toys Due to Risk of Serious Injury or Death from Choking Hazard.

DESCRIPTION: This recall involves My First Snowman toy, which is sold with a

removable plastic top. The toy snowman was sold with additional removable facial features and mittens. The snowman's hat is black and red with a gray snowflake. The snowman is about 17 inches high and is white, with purple mittens, blue ears, one blue eye, one green eye, an orange nose and red and orange buttons on the front. The Step2 logo is on the front of the snowman. The top hat is battery powered. Only snowman toys manufactured in December 2023 and April 2024 are included in this recall. The date code appears on the bottom of the hat near the battery compartment. The date code is listed in a dial format, showing month and year of production.

REMEDY: Consumers should stop using the recalled snowman immediately, take off the toy snowman's hat and keep it away from children. Contact The Step2 Company for instructions on how to dispose of the top hat and receive a free replacement. The Step2 Company is notifying all known purchasers directly.

DESCRIPTION: This recall involves Playworld Unity Teeter Tunnels with part numbers ZZXX0182, ZZXX0182S, ZZXX0192 and ZZXX0192S. The seesaws allow multiple children to stand, sit and lie down on them and to crawl into a tunnel. The part number appears on the original purchase order and on the installation instructions.

REMEDY: Consumers should immediately stop using the recalled teeter tunnels and contact Playworld Systems to schedule a free repair. Playworld Systems will send a certified playground installer to each location to repair the unit. Playworld Systems is contacting all known purchasers directly and will request that consumers place the teeter tunnels out of service until the repair is completed.

DESCRIPTION: This recall involves five different styles of Holiday Lane-branded infant footed pajamas. The cotton pajamas were sold in infant sizes 0-3 months, 3-6 months and 6-9 months. "Holiday Lane" is printed on the pajamas' neck label. The size and PID/Style numbers are printed on the care instruction tag located on the pajamas' side seam:

REMEDY: Consumers should immediately stop using the recalled pajamas, take them away from children and contact Macy's for instructions on how to receive a refund. DESCRIPTION: This recall involves Nezmdi-branded electric infant swings. They were sold in pink and have a white base with a black control panel, star and moon hanging plush toys, a pillow, a seat cover and a mosquito net with a canopy. They measure about 25.5 inches in length, 25.5 inches in width and 20.8 inches in height and come with a remote control and a USB cable. A leather patch with the brand "Nezmdi" is sewn onto the restraints. "Model Number: S0008" and "Baby Swing Chair" are printed on a label located under the seat.

REMEDY: Consumers should stop using the recalled infant swings immediately and contact Nezmdi for a full refund. Consumers should send a photo of the swing cover cut in half with "Recalled" written with permanent marker on its base to viingpengds@163.com, and then dispose of the swing in accordance with state and local procedures. Nezmdi is contacting all known purchasers directly.

DESCRIPTION: This recall involves the

DTR Plush Bag Stitch and DTR Plush Bag Angel. The Stitch plush bags were sold in blue and the Angel bags were sold in purple. The bags measure about 10 inches long and 8 inches wide, with a swing tag care label that hangs off the side of the bag.

REMEDY: Consumers should immediately take the recalled plush bags away from children, stop using them and return them to a Primark store for a full refund in the form of the original payment.

DESCRIPTION: This recall involves multiple child safety gates sold by five different third-party sellers on Amazon.com. The gates have model numbers and cohort information listed on their tracking label, located on the bottom rail. The gates are all made of steel and ABS plastic and were sold in white and black colors. They can be pressure-mounted and/or drill-mounted and vary in several sizes. Some gates have a secondary pet door.

REMEDY: Consumers should stop using the recalled gates immediately and contact the third-party seller by email for information on how to dispose of the product and submit proof of destruction to obtain a full refund. The third-party sellers and Amazon are contacting all known purchasers directly.

The 4-in-1 high chairs were sold in green, gray and pink and have a removable seat cushion, a detachable tray, a footrest and storage space underneath the seat. They convert from a high chair into a low chair, rocking chair and slide.

REMEDY: Consumers should stop using and disassemble the recalled high chairs immediately and contact Boyro Baby for instructions on receiving a full refund. The instructions will include instructions on cutting the restraint system and seat cushions, and emailing photos of the disassembled and destroyed pieces of the high chair to boyrobaby@outlook.com.
