## PRODUCT RECALLS

**PRODUCT/FIRM:** Meaicezli Play Purse Sets Recalled Due to Risk of Serious Injury or Death from Battery

Ingestion; Violates Mandatory Standard for Toys; Sold on Amazon by Angeer-n Amazon

**DESCRIPTION:** This recall involves

Meaicezli Play Purse Sets. The Play Purse Sets come in pink and contain a bag with toy sunglasses, toy camera, toy money, toy make up kit, toy lipstick, wallet, hair bow, eye mask, toy passport, plastic toy credit cards, toy cell phone, and toy writing tablet. Both the toy phone and toy writing tablet come with a button or coin cell battery installed.

**REMEDIY:** Consumers should stop using the toy purse set immediately, take the toy cell phone and writing tablet away from children and contact Angeer-US for a full refund. **PRODUCT/FIRM:** Pacific Cycle Recalls Schwinn Ovation Bicycle Child Carriers Due to Fall Hazard

**DESCRIPTION:** This recall involves the Schwinn Ovation Bicycle Child Carrier, Model SW80356. The product is black with a gray seat cushion, black harness straps, and red buckles. It attaches to a rear bike rack that was sold with the carrier. The impacted date codes are 712A0329BE and 712A0421BE. The model number and date code are located on the underside of the carrier.

**REMEDIY:** Consumers should immediately stop using the recalled carriers and contact Pacific Cycle for a full refund..

**PRODUCT/FIRM:** Luyuan Recalls Youth ATVs Due to Risk of Serious Injury or Death from Crash Hazard; Violate Mandatory Standard for All-Terrain Vehicles

**DESCRIPTION:** This recall involves the X-Pro Eagle 40cc Youth ATV, Model CARTOONS and the FRP Sahara 40cc Youth ATV, Model SHR 40-RED-M. The ATVs come in various colors. Look for "X PRO" labels on the sides of the plastic body or "FRP" labels on the front small plastic cover as well as the sides of the plastic body.

**REMEDIY:** Consumers should immediately stop using the X-Pro Eagle 40cc Youth ATVs and FRP Sahara 40cc Youth ATVs and contact Luyuan for a free repair from an authorized repair shop.

**PRODUCT/FIRM:** YCXXKJ Baby Bath Seats Recalled Due to Risk of Serious Injury or Death to Children from Drowning; Violate Mandatory Standard for Infant Bath Seats; Sold on Amazon by BenTalk

**DESCRIPTION:** This recall involves YCXXKJ-branded baby bath seats sold in blue, gray, pink, and yellow. The bath seats have two detachable arms that serve as a restraint, four suction cups on the bottom, and three toys; a duck, a turtle, and a whale. "Model: YD-1958" is printed on a tracking label located on the back of the bath seat.

**REMEDIY:** Consumers should immediately stop using the recalled bath seats and contact BenTalk to request a full refund. Consumers should send two photos of the recalled bath seats to BenTalk at [bentalkhere@outlook.com](mailto:bentalkhere@outlook.com). The first photo should have "Recalled" written on the front of the bath seat in permanent marker. The second photo should show the bath seat disassembled with the components removed.

**PRODUCT/FIRM:** Uuoebbe Infant Walkers Recalled Due to Risk of Serious Injury or Death from Fall and Entrapment Hazards; Violate Mandatory Standard for Infant Walkers; Sold on Amazon by BaoD

**DESCRIPTION:** This recall involves Uuoebbe Infant Walkers. The infant walkers are collapsible with a round base, eight wheels, and seven adjustable height settings. They were sold in gray, black and pink. "Production Batch: 7654" is printed on a tracking label located under the seat.

**REMEDIY:** Consumers should stop using the recalled infant walkers immediately and contact BaoD for a full refund. Consumers should disassemble the walker, remove the fabric seat, write "Recalled" on the top of the tray in permanent marker, and email a photo of the recalled infant walker to BaoD at [Uuoebbreccalls@outlook.com](mailto:Uuoebbreccalls@outlook.com). **DESCRIPTION:** This recall involves SKCAIHT-branded Mermaid costumes. The children's recalled costumes consist of a dress and a matching headband. The glittery dress has a blue, purple and pink fabric skirt and a knit purple strapless top with a white starfish and other sea-themed embellishments. The headband has white ears with blue seashells, pink starfish and a mermaid tail. The costumes were sold in children's size XL.

**REMEDIY:** Consumers should immediately stop using the recalled costumes and take them away from children. Contact SKCAIHT Direct for a full refund. Consumers should cut the dress and submit a photo of the destroyed costume to [pafiney@outlook.com](mailto:pafiney@outlook.com).

**PRODUCT/FIRM:** Primark Recalls Little Bear 2-Pack Soother Clips Due to Choking and Laceration Hazards

**DESCRIPTION:** This recall involves the Primark 2-pack Soother Clip - Little Bear. It is a cloth strap with small bears on it and a wooden button to clip on to a child's clothing, designed to hold a pacifier. The product code, 991139699, is printed on the price tag located on the back of the product packaging.

**REMEDIY:** Consumers should immediately stop using the recalled soother clips and return them to a Primark store for a full refund in the original form of payment.

**PRODUCT/FIRM:** KTEBO Writing Tablet Toys Recalled Due to Risk of Serious Injury or Death from Battery Ingestion; Violates Mandatory Standard for Toys; Sold on Amazon by KTEBO

**DESCRIPTION:** This recall involves KTEBO-branded Writing Tablet Toys. The products were sold in sets of two and came in four color variations (pink/blue, green/yellow, orange/blue, purple/red) and two sizes (8.5 inches and 10 inches) with a matching-colored stylus.

**REMEDIY:** Consumers should immediately stop using the recalled writing tablet toys and contact KTEBO for a free replacement set of tablet toys. Consumers should write "RECALLED" on the back of both tablet toys that came in the set, take a photo of the marked tablet toys, and submit

the photos to [writing-tablet-recall@ktebo.com](mailto:writing-tablet-recall@ktebo.com) with "Recall Proof" and their name in the subject line.

**PRODUCT/FIRM:** Cubimana Building Toy Sets Recalled Due to Risk of Serious Injury or Death from Battery Ingestion; Violates Mandatory Standard for Toys; Sold on Shein by Vatos Toys

**DESCRIPTION:** This recall involves Cubimana-branded treehouse building toy sets. The recalled sets consist of 618 multi-colored pieces to build a three-tier treehouse that lights up. A clear piece containing a LED light is attached with a wire to a brown piece that has a preinstalled button cell battery. The Cubimana logo and "Tree House" appear on the front and back of the product packaging. "NO. HG1015" along with the number of pieces appear on the front.

**REMEDY:** Consumers should immediately stop using the recalled toy sets, take them away from children, and remove and properly dispose of the batteries. Contact Vatos Toys for a full refund. Consumers should throw the piece with the LED light away and send a photo of the product in the trash to [shein.us@vatostoys.com](mailto:shein.us@vatostoys.com)

**PRODUCT/FIRM:** Little Pea Shop Crib Bumpers Recalled Due to Risk of Serious Injury or Death from Suffocation; Violates Federal Crib Bumper Ban; Sold by Little Pea Shop

**DESCRIPTION:** This recall involves two styles of Little Pea Shop-branded padded crib bumpers. The "Waffle Bedding Accessory" style was sold as bumper pads in gray, pink, blue and white and in four different lengths: 23.5 inches, 47 inches, 78.5 inches and 94.5 inches. The "Plush Crib Bumper" style was sold as vertical crib slat covers with Velcro in beige and ivory in the shape of bears and rabbits or a star pattern.

**REMEDY:** Consumers should immediately stop using the recalled crib bumpers and contact Little Pea Shop for a full refund. Consumers should remove the crib bumpers, cut the padding and email a photo of the destroyed bumpers to [support@littlepeashop.com](mailto:support@littlepeashop.com).

**PRODUCT/FIRM:** HydroJug Recalls 14-Ounce Children's Sport Tumblers Due to Choking Hazard

**DESCRIPTION:** This recall involves the 14-ounce sport tumbler with serial number 235010 or no serial number on the bottom of the tumbler under the rubber boot. The handle with the rivets is attached to the lid of the tumbler. The recalled tumbler was sold in five patterns: Cowgirl, Daisy Checkers, Dinosaur, Sport and Bows.

**REMEDY:** Consumers should immediately stop using the recalled 14-ounce sport tumbler and contact HydroJug for a free replacement lid. Consumers should email HydroJug at [service@thehydrojug.com](mailto:service@thehydrojug.com) and provide order details (if available), shipping address and photos of the bottom of the tumbler showing the serial number or that there is no serial number. Consumers will be asked to include photos of the recalled tumbler lid permanently marked with the word "Recalled" and to dispose of the recalled tumbler lid. HydroJug will confirm eligibility and send a replacement lid.

**PRODUCT/FIRM:** CreateOn Recalls Pip-Cubes Due to Risk of Serious Injury or Death from Magnet Ingestion Hazard

**DESCRIPTION:** This recall involves CreateOn Crayola-branded pip-Cubes, which are magnetic building cubes sold in Bold Colors and Glitter in sets of 24 or 27 cubes. The Bold Colors cubes are red, green, blue and yellow. The Glitter cubes are purple, pink, blue and green and have glitter on them. "Crayola" is imprinted on the left side of each cube. The model/UPC numbers of the recalled cubes are located can be found on the bottom of the product packaging.

**REMEDY:** Consumers should immediately stop using the recalled magnetic building cubes, take them away from children and contact CreateOn to receive a replacement set of pip-cubes. Consumers will receive a pre-paid label to return the recalled magnetic cubes in order to receive the replacement.

**PRODUCT/FIRM:** Outdoor Master Children's and Youth Helmets Recalled Due to Risk of Serious Injury or Death from Head Injury; Violates Mandatory Standard for Bicycle Helmets; Sold and Imported by Outdoor Master

**DESCRIPTION:** This recall involves two models of Outdoor Master-branded children's and youth bicycle/multi-purpose helmets. Helmet model OM-TD BIKE is blue with a dinosaur print, has black padding, black straps, a black buckle and a black plastic knob at the back of the helmet for adjusting the fitting; and was sold in children's size small (S), fitting a head circumference from 48 to 52 cm (18.9 to 20.5 inches). "OM-TD BIKE" and "05/2024" (the manufacture date) is printed on a label inside the helmet, and the brand is printed on the back of the helmet. Helmet model OM-KSKB is deep green with black padding, yellow straps, a black buckle and a black plastic knob at the back of the helmet for adjusting the fitting; and was sold in youth size small (S), fitting a head circumference from 46 to 52 cm (18.1 to 20.5 inches). "OM-KSKB" and "11/2022" (the manufacture date) is printed on a label inside the helmet and the brand is printed on the front and back of the helmet.

**REMEDIY:** Consumers should immediately stop using the recalled helmets and contact Outdoor Master for instructions on how to register for a full refund.

**DESCRIPTION:** This recall involves baby high chairs sold in beige or pink with a matching removable seat cushion, detachable tray, and footrest. The high chairs convert into an infant swing and are reclinable and collapsible. "Product No.: HA-028" is printed on a tracking label on the seatback.

**REMEDIY:** Consumers should immediately stop using the recalled high chairs and contact Rotinyard for a full refund. Consumers should disassemble the high chairs, cut the restraints and fabric seat cushion insert, and email photos of the destroyed restraints and cushion to [trailblazeramz@outlook.com](mailto:trailblazeramz@outlook.com). Once the photos are received, Rotinyard will issue a full refund.

**DESCRIPTION:** This recall involves Sofoliana and Glotika baby loungers. The recalled baby loungers are rectangular in shape and are made of a foam sleeping pad and padded bumpers with a cloth cover. The Sofoliana baby loungers are dark gray with a ribbon tie at the bottom of the lounger. The Glotika baby loungers zip up into a bag with an adjustable strap and came in the following colors: gray-rocket, pink-heart and white-elephant, with the printed design on the inside of the lounger. Neither baby loungers have any markings or labeling.

**REMEDIY:** Consumers should immediately stop using the recalled baby loungers and contact Bosen US for a full refund. Consumers should remove the foam and pad from the baby lounger's cover and cut the cover, foam and pad in half. **DESCRIPTION:** This recall involves Ikuso-branded safety pressure-mounted safety gates. The white steel safety gates were sold in two adjustable size ranges: between 30 inches and 48 inches (model Door-Gen1-123) and between 30 inches and 63 inches (model Door-Gen1-159). "Ikuso" is printed on the latch on the top of the gates, and the model numbers are on labels located on the side-post under the latch of the gate.

**REMEDIY:** Consumers should immediately stop using the recalled safety gates and contact Ikuso to request a full refund. They were sold in the following colors and prints: blue, brown, brown leaves and pink flower. "Macardac" is printed on an attached tag on the outside of the baby lounger's cover.

**REMEDY:** Consumers should immediately stop using the recalled baby loungers and contact Macardac Products for a full refund. Consumers should remove the foam and pads from the baby lounger's cover and cut the cover, foam and pad in half. **DESCRIPTION:** This recall involves play yards that have black fabric sides and mesh panels bordered in gray. The top rails are covered with white fabric with a multi-colored print with bear faces, paws and the word "bear". The play yards include a mattress with the same bear print. "Model: P700" and "Production Date: 202503" are printed on the packaging and on a removable tag included with the play yard.

**REMEDY:** Consumers should immediately stop using the recalled play yards and contact Anna Queen for a full refund. Consumers should disassemble the fabric cover from the play yard frame, cut up the cover and mattress pad and email a photo of the destroyed play yard to [ingerservice@outlook.com](mailto:ingerservice@outlook.com) to obtain a full refund. **DESCRIPTION:** This recall involves children's Grow 'N Stow Folding Learning Tower with model number LP01711 and date codes, in YYYYMM format, from 202409 to 202501. The model number and date code are located on a label on the underside of the platform. The product is made of wood with a natural finish. "Learning Tower" is printed on the top rail of the tower.

**REMEDY:** Consumers should immediately stop using the recalled Grow 'N Stow Folding Learning Tower, keep it away from children and contact Little Partners, to receive a free repair kit, that includes a new crossbar with pin tabs and installation instructions. The new crossbar will have a sticker indicating that it is no longer part of the recall. Consumers should remove the old crossbar and dispose of it.

**DESCRIPTION:** This recall involves Romogniz Fabric 12- and 13-Drawer Dressers. The dressers come in rustic brown, black, pink and white and have a metal frame and wooden top. The 12-drawer dresser has 12 collapsable fabric drawers, and the 13-drawer dresser has 13 collapsable fabric drawers. The 12-drawer dressers measure about 52 inches by 12 inches by 35 inches. The 13-drawer dressers measure about 35 inches by 11 inches by 55 inches. The 12-drawer dressers have "Model No.: R99MWM12CHMW" printed on the back and the 13-drawer dressers have "Model No.: R99M9C4CLHW" printed on the back.

**REMEDIY:** Consumers should stop using the recalled dressers immediately, if they are not anchored to the wall, and place them in an area that children cannot access.
